Dear Parents:

Attached please find the descriptions of all events scheduled for the 2010-2011 school year. Each family in the "full participating" tuition category is responsible for **20 working points**. We ask that you please select at least 30 working points on the attached selection sheet so that your alternate choices can be considered if needed. If you are choosing a chair position, please select 40 points. List the events you would like to work in the order of your preference. Your order of preference will be given first consideration when assigning points. If you submit a form with less than 30 or 40 working points listed, we reserve the right to assign you to any events as needed.

In addition to the 20 working points, each family will *also* be responsible for the following:

1. to purchase a minimum of \$2,000. per year (\$200. Per month) of Grocery Certificates;
2. to purchase 1 ticket to the St. Patrick's Day Dinner Dance, Golf Outing/Tricky Tray Dinner Ticket OR \$70 in merchandise from the Gift Wrap sale;
3. to sell or purchase 10 Calendar Raffle tickets @\$10. Per ticket; and
4. to earn 20 points by working the events I will be assigned by the H.S.A. Executive Board.

FAILURE TO MEET ANY OF THESE OBLIGATIONS, WILL RESULT IN A SURCHARGE TO YOUR TUITION.

No other points will be assigned unless authorized by the Executive Board and approved by Mr. James Newman. Extenuating circumstances need to be discussed with Mr. James Newman.

- (4) Failure to fulfill your 20 working points will result in a penalty of \$3,400. For every 5 points not worked the penalty will be \$850.00.
